

PERSONAL DATA PROTECTION NOTICE FOR HEXXON DEVELOPMENT SDN BHD

Hexxon Development Sdn Bhd respects and is committed to the protection of your personal information and your privacy. In this Personal Data Protection Notice, “we”, “us” and “our” refers to Hexxon, and “you” and “your” includes third parties whose personal data you have provided to Hexxon.

This Personal Data Protection Notice explains how we collect and handle your personal information, including your sensitive personal information in accordance with the Malaysian Personal Data Protection Act 2010. Please note that Hexxon may amend this Personal Data Protection Notice at any time without prior notice and will publish the amended or revised Personal Data Protection Notice on our website or by email.

1. TYPE OF PERSONAL INFORMATION

Personal Information may be subject to applicable data protection, privacy and other similar laws and may include information such as name, identity card number, passport number, address, gender and other information deemed necessary.

2. PURPOSES OF COLLECTING PERSONAL INFORMATION

The Personal Information you have provided to us will be used or processed by us for, amongst others, the following purposes:

- a. present or future delivery of various communication tools for our services or products, inclusive of marketing related services or products to you;
- b. enable us to send you information by way of e-mail, available telecommunication means (be it telephone calls, text messages, fax and others) or social media communication means about our products and services offered, by our appointed third parties. In view of this, we will maintain control and safety over your Personal Information at our best efforts;
- c. customer relationship management needs;
- d. to perform related marketing and customer profiling activities as deemed necessary, in connection with our services and related products;
- e. as a way of communication from us to you to perform necessary transaction, agreement and/or contract in relation to the products offered;
- f. our internal record keeping use;

3. DISCLOSURE

Your Personal Information provided to us will generally be kept confidential. You hereby consent and authorise us to provide or disclose your Personal Information to the following categories of parties, whenever deemed necessary without prior notice:

- a. any related companies and subsidiaries of Hexxon Development Sdn Bhd and/or its subsidiaries, at present or future establishment;
- b. our appointed business partners and third party service or product providers that provide related services or products in connection with our business;
- c. our auditors, consultants, accountants, lawyers or other financial or professional advisers, deemed necessary for their business nature;
- d. government agencies, statutory authorities and industry regulators.

4. CONSEQUENCES OF INSUFFICIENT OR INCOMPLETE PERSONAL INFORMATION

The failure to supply such Personal Information:

may result in us being unable to reach out to our customers with the notices, services and/or products, launches, marketing & promotional activities and events, inclusive of current and future announcement and activities, deemed necessary;

may affect the ability of the parties involved to enter into the necessary transactions/arrangements.

5. DATA SECURITY

We have implemented reasonable physical, technical and procedural measures to secure your personal information from accidental loss and from unauthorized or accidental access, use, alteration, and disclosure. All information you provide to us is stored on our secure servers.

6. TRANSFER AND SHARING OF INFORMATION

Whenever we deem necessary or appropriate for the purposes of information storage or processing or providing any service or product to you, we may transfer your Personal Information to appointed third party service or product providers within or outside the country in which we are established, under conditions of confidentiality and similar levels of safety measures, without notice.

7. RIGHT TO ACCESS AND CORRECT PERSONAL INFORMATION

You have the right to access and correct your personal information held by us (subject always to certain exemptions). We will make every endeavour to ensure your personal information is accurate and up to date therefore we ask that if there are changes to your information you should notify us directly.
